

CAST/CREW CONTRACT

Effective PLACEHOLDER

I, _____ (hereby known as INDEPENDENT CREW MEMBER aka ICM), agree to uphold the role of _____ for the PLACEHOLDER project YEAR and agree to all the following terms laid out by the LUX: Film Production Club.

HOLD HARMLESS: The ICM agrees to indemnify and hold the LUX: Film Production Club harmless from any claim, demand, suit, loss and expense, including attorney’s fees, based on bodily injury, sickness, death or property damage caused by any action, omission or negligence on the part of the ICM, arising out of the performance of work under this Agreement either by the ICM or by others under the supervision of the ICM.

TERMS OF PAYMENT: This project will be UNCOMPENSATED.

EQUIPMENT, TOOLS, MATERIALS, AND SUPPLIES: LUX: Film Production Club is not responsible for damage or loss of equipment rented by the ICM. LUX: Film Production Club will help provide access to equipment, but is not responsible for providing ICM with equipment. ICM will provide all materials and supplies at their sole expense.

INTELLECTUAL PROPERTY: To the extent that the ICM creates any fixed and tangible forms of PROPERTY: expression or any other works that may be protected by patent, copyright, or trade secrets law (“Work Product”) in connection with the Services, the ICM shall be deemed upon such creation to have irrevocably assigned, transferred, and conveyed to LUX: Film Production Club all right, title, and interest worldwide in and to all such Work Product and all rights related to such Work Product. LUX: Film Production Club agrees to use the Work Product with credit attributed to the Crew if practical. The Crew may display the Work Product for personal demonstration or portfolio purposes only with permission granted from the LUX: Film Production Club.

CONFIDENTIALITY: The ICM shall treat as confidential all data, records and accounts, information, operations, policies, procedures, personnel, marketing plans or prospects and all other information, which becomes known to it through its activities hereunder and which is not otherwise in the public domain or rightfully obtained from another source. During the term and after termination of its services to LUX: Film Production Club, ICM shall not use or disclose any such protected information, except in accordance with the terms of this agreement or as required by law, regulation or court order. All records, reports, notices, valuations, lists, data and other documents prepared by ICM shall be the property of LUX: Film Production Club and ICM shall deliver any such documents to LUX upon LUX’s request.

CHOICE OF LAW: Any disputes under this agreement shall be decided in accordance with Washington State Law.

ENTIRE AGREEMENT: This entire agreement cannot be changed or modified orally.

SEVERABILITY: If any part of this agreement shall be held unenforceable, the rest of this agreement shall remain nevertheless in effect.
